Launch of Carlsberg Young Researcher Fellowship Project 'InterAct'

September 2021 marks the start of InterAct with two new researchers, **Postdoc Viktor Weber** and **PhD student Ana Stella Ebbersmeyer**, joining the provide an account of the actors involved in the international law-making processes addressing climate change impacts of shipping, including their rol synergies for sustainable shipping. The project will run over the course of the next three years.





#### **New PhD project on Arctic Resilience and Law**

New PhD project on Arctic resilience, carried out by Johanna Sophie Bürkert, began in September (supervised by Associate Prof. Beatriz Martinez Romera). The research focuses on the nexus between law and resilience in the Arctic. By studying the Arctic as a socio-ecological system, the project aims to develop ways in which to further the Arctic's resilience in the face of climate change.

#### **New PhD project on Climate Litigation and the Energy** Sector

Current developments in climate change litigation and the energy sector are the focus of Pernille Holten Poulsen's PhD research, supervised by Prof. Kristian Cedervall Lauta and Associate Prof. Beatriz Martinez Romera.

The project carries out a case law analysis of tort and corporate law climate-related litigation.
