




Central Purchasing Bodies in Finland

- Hansel Ltd is a central purchasing body for the whole public administration in Finland
- Hansel is the oldest (over 80 years old) and the largest CPB in Finland
- Hansel is the only CPB that is governed by an Act in which Hansel's activities and customers are defined.
- Hansel's joint procurement amounts to around 4 % of the whole procurement spending in Finland
- Other central purchasing bodies in Finland are local or regional central purchasing bodies for councils, municipilaties and counties.








Hansel's key indicators 2022



Challenges and main issues in Finland

- Long legal proceedings for appeals taken to court
- Shortage of professionals and experts in the field of procurement
- Scattered and fragmented procurement operations and units
- Procurement units are required to join framework agreements beforehand and they need to be named already in the contract notice
- Conflicting political aims set for joint procurement
- Opposite expectations and wishes from procurement units and suppliers from joint procurements
- Differing amounts of work and expertice required from CPB, procurement units and suppliers depending on chosen model of joint procurement
- Current themes: Sustainability, prepardness, data protection and data security





Working for sustainability since 2006

- Hansel has its own sustainability team that coordinates all sustainability activities carried out by the company.
- Financial sustainability has always been one of the cornerstones of operations.
- Promoting social sustainability became a significant theme alongside environmental sustainability in 2017.
- Hansel's sustainability report is prepared in accordance with the GRI Sustainability Reporting Standards, and it is available in the annual report.
- Hansel's strategy for 2019-2023 sets a goal for Hansel to be a trailblazer in responsible and effective procurement.
- Hansel has an active participation in Finland's Competence Centre for Sustainable and Innovative Public
 Procurement (KEINO) which supports and helps Finnish public contracting authorities with the development of
 sustainable and innovative procurement





This is how we require sustainability

- The possibility to promote sustainability is always assessed during the preparation of joint procurement.
- We promote sustainability in the following:
 - Requirements set for the object of procurement
 - Selection criteria
 - Comparison criteria
 - Agreement terms and conditions
 - The Code of Conduct for social sustainability regarding high-risk sectors
- We set the requirements in the invitation to tender, and they must be verifiable.
- We challenge the markets to be sustainable.
 - We address sustainability in market interaction.
 - We constantly seek ways to improve sustainability in joint procurement.

- Development of open procurement data:
 - Eg. Hansel has developed an Open Procurement Service (www.tutkihankintoja.fi) which allows citizens and companies to explore state and municipal procurement data. It is an Open data source that gives information on the purchases made by the state and Finnish municipalities as well as how public funds are being spent + information on current market conditions.



Other future possibilities

- Customer-driven approach to joint procurement
- Joint procurement brings more competitive prices, less administrative costs for other contracting units and CPBs are not found to favour any particular suppliers.
- Development of Hilma –official service for notices on public procurement in Finland
- New Government starting soon: public spending and fiscal consolidation main issues. Expectation is to bring savings in public procurement.
